#### ESTABLISHMENT OF THE COCKREL/RAVITZ MEMORIAL ENDOWED SCHOLARSHIP

### Recommendation

It is recommended that the Board of Governors establish the Cockrel/Ravitz Memorial Endowed Scholarship.

This endowment fund is established to recognize scholastic achievement, encourage continued progress and provide assistance to students in financing their education in the Law School. The fund may be used to provide scholarships to students interested in practicing public interest law after graduation, or to make loan repayment awards to graduates of the Wayne State University Law School who are practicing public interest law.

# **Background**

An attorney and politician, Ken Cockrel served as one of Detroit's most powerful voices for social justice during the 1960s and 1970s. As a law student and self-described Marxist-Leninist, Cockrel was one of the founders of the League of Revolutionary Black Workers, and relentlessly challenged the racial and economic status quo in Detroit through his defense of African Americans in the courtroom, as an activist against police brutality, and then during a term as a city council member. Through his pursuit of social justice for the people of Detroit, Cockrel became a leader in the city and was touted widely as a future mayor at the time of his sudden death in 1989.

Throughout his career, Justin Charles "Chuck" Ravitz made a difference and changed lives. During his years as a young lawyer, he rallied against the conservative establishment, helping to shut down a lethal decoy police squad, changed a jury selection process that had favored whites, and improved the then-despicable Wayne County Jail conditions. He dazzled the legal community with his intellect and fairness, and still managed to rule with his heart. In his law firm, days after leaving the bench, he battled for handicap accessibility on city buses, represented wrongly convicted clients, many of whom society preferred to overlook, and sought justice for victims of sexual abuse.

The endowment is established with a transfer from the dissolution of the Kenneth V. Cockrel Endowed Scholarship and the Justin C. Ravitz Memorial Endowed Scholarship.

# ESTABLISHMENT OF THE JAMES E. PUKLIN, M.D., ENDOWED AWARD FOR INTERNATIONAL OPPORTUNITIES

### Recommendation

It is recommended that the Board of Governors establish the James E. Puklin, M.D., Endowed Award for International Opportunities.

The purpose of this fund is to pay the expenses incurred by residents, fellows or medical students traveling abroad to attend international ophthalmologic electives and activities, and to provide funding to bring any faculty, residents, fellows or medical students in institutions located abroad to the Kresqe Eye Institute to lecture or to observe its activities.

# **Background**

Dr. James E. Puklin has been a prominent faculty member of the Kresge Eye Institute (KEI) since 1989. Dr. Puklin graduated from the Rosalind Franklin University of Medicine Science/Chicago Medical School in 1968. He then was a lieutenant in the Navy Medical Corps from 1969 to 1971, followed by a residency at Northwestern University from 1971 to 1974. He held a retina fellowship at the University of Illinois from 1974 to 1975.

Before joining the faculty at the Wayne State University Department of Ophthalmology, Dr. Puklin was an assistant professor at Yale University School of Medicine from 1976 to 1979, followed by associate professor there until 1985. From 1986 to 1989, he was professor of clinical ophthalmology at Northwestern University Medical School.

Dr. Puklin has mentored and trained dozens of residents and fellows at KEI and has authored numerous scientific papers.

Dr. Puklin is a world traveler who has developed relationships in India and Russia. The endowed fund will provide financial assistance to faculty, residents, fellows or medical students traveling abroad for international ophthalmologic electives and activities, or to bring any faculty, residents, fellows or medical students in institutions located abroad to KEI to lecture or to observe its activities.

The endowment is established with a gift of \$25,000 from University Eye Associates.

# **Background**

Throughout his 35-year career as a social worker, therapist, clinical supervisor, consultant and administrator, Donald J. Roberts demonstrated a strong commitment to the disadvantaged. He was the executive director of the Neighborhood Service Organization of Detroit, and senior therapist and clinical supervisor at Self-Help Addiction Rehabilitation House. He also maintained a private practice. Roberts held numerous community leadership positions at organizations such as the Metropolitan Detroit Congress of Racial Equality, the National Association of Black Social Workers, Black United Fund and the Inner City Business Improvement Forum.

In 1999, an account for the Donald J. Roberts Memorial Endowed Scholarship was created with a gift of \$2,000. The purpose of the scholarship is to support students at the Wayne State University School of Social Work where Roberts earned a master of social work and served as an assistant professor. At the time that the account was created, the threshold amount for an endowment was \$10,000. Since 1999, the university has received 55 gifts from 28 donors for deposit in the scholarship account, which now has reached the original threshold amount for an endowment. Accordingly, the university now intends to establish the Donald J. Roberts Memorial Endowed Scholarship.

The endowment is established with gifts totaling \$10,000 for this purpose.

Now upon Professor Tini's retirement, this endowment fund will be converted to an endowed scholarship, per the donors' intentions stipulated in the agreement.
