C. 6241 Cass – Racer Trust Parking Lot Improvements (Budget and Finance)

Authorizes the President or his designee to proceed with the design, solicitation of bids and the awarding of contracts to complete improvement to the parking lot located at 6241 Cass Avenue (Racer Trust Lot) for project cost not to exceed \$650,000. Funding for this project will be provided from the Parking and Transportation Services Auxiliary.

D. Engineering Research Laboratory Upgrades (Budget and Finance)

Authorizes the President or his designee to increase the project budget from \$1,000,000 to \$2,500,000 to complete the renovation and upgrade of eight research laboratories in the Engineering Building Funding for this project will be provided from the Depreciation Reserve (\$600,000), the Research Facilities fund (\$600,000) and the Office of the Provost (\$300,000).

E. Scott Hall Roof Replacement (Budget and Finance)

Authorizes the President or his designee to award contracts to replace the penthouse roof of Scott Hall for a project cost not to exceed \$550,000. Funding for this project will be from the deferred maintenance reserve.

- The James H. McMicking Endowed Scholarship (Fund Functioning as an Endowment) to recognize scholastic achievement, encourage continued progress, and provide assistance to students in financing their education in the College of Engineering Department of Chemical Engineering. \$76.626
- 3. The Medical Center Emergency Services (MCES) Endowment for the Advancement of Excellence in Medical Education and Research. \$41,000
