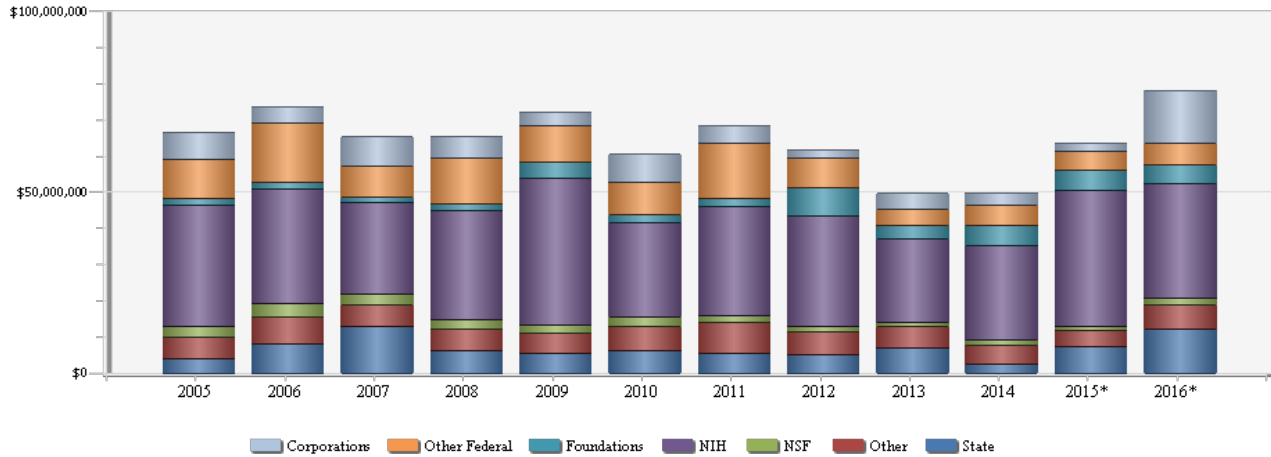

**TOTAL AWARDS – OBLIGATED AMOUNTS RECEIVED – Q2**



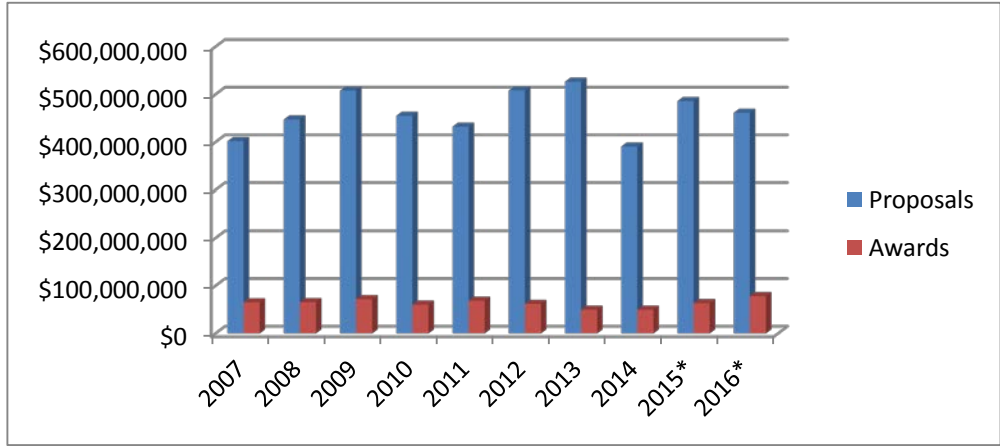

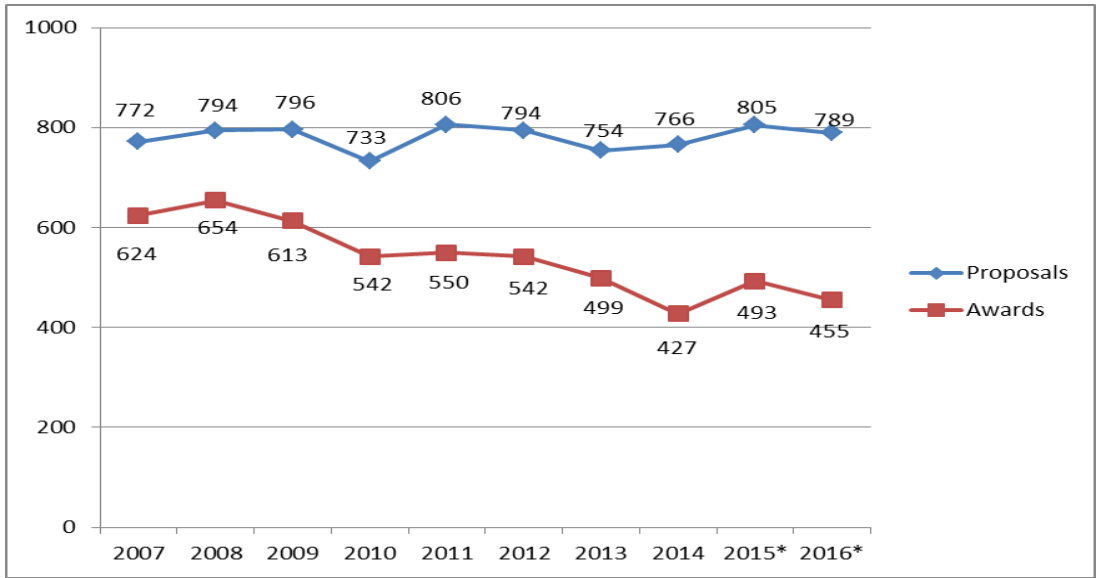
