Wayne State University gave her a chance to enter and either succeed or fail. She did well, and as a result, had a much better life than her parents. Helene Burns always supported Marilynn in her education, and she dedicates this scholarship to her mother with gratitude and in loving memory.

The purpose of the endowment is to support training and education for residents and fellows in the perinatal/NICU program, with an emphasis on recognizing the need for mental health counseling for parents of prematurely born infants.

Background

Dr. Rosalind Griffin has established this endowment in honor of her grandson to enhance neonatal research and expand mental health support to those affected by premature birth.

Dr. Griffin has pledged \$25,000 to establish this endowment.

ESTABLISHMENT OF THE HARRIS LITERACY PROGRAM

Recommendation

It is recommended that the Board of Governors establish the Harris Literacy Program.

In furtherance of Wayne State University's ability to promote literacy within the city of Detroit and its commitment to community outreach, the Harris Literacy Program will be administered by the Office of the Provost at Wayne State University and led by the Associate Vice President for Educational Outreach and International Programs.

Background

On October 25, 2012, Mort Harris made an extraordinary gift of \$2.5 million to establish an endowment to support the Mort Harris Office for Adult Literacy in the Irvin D. Reid Honors College. Now, Mr. Harris, in consideration of the gifts and pledges of others, wishes, and the university agrees, to repurpose the endowment to establish and support the Harris Literacy Program at Wayne State University, which will be administered by the Office of the Provost.

Of the \$2.5 million received by the university, \$1,250,000 was used to establish the Mort Harris Office for Adult Literacy Endowment Fund (060539-601G2C) and the remaining \$1,250,000 was deposited into the corresponding beneficiary account (477243-2912H). The current balances in the Mort Harris Office for Adult Literacy corpus and beneficiary accounts are \$1,387,521.04 and \$1,126,385.10, respectively. Of the \$1,126,385.10 in the beneficiary account, \$750,000 will be used to create a new fund functioning as an endowment and the remainder will be transferred to the new beneficiary account for immediate spending.

With the Board of Governors' approval, the donor wishes to change the purpose of the above referenced corpus and beneficiary accounts to support the Harris Literacy Program in the Office of the Provost. Also, the corpus and beneficiary accounts shall both be renamed the Harris Literacy Program Endowment.

Background

Raphael Patai (1911-1996) was a prominent cultural anthropologist, historian and biblical scholar of international reputation. He was the author of more than three dozen books on Jewish and Arab culture, history, politics, psychology and folklore.

The Raphael Patai Series in Jewish Folklore and Anthropology was established at the Wayne State University Press by Raphael Patai in 1988. The series includes anthropological and folkloric studies of Jewish culture past and present, covering a wide range of topics and illuminating a culturally rich and diverse Jewish heritage throughout the world. As of 2014, more than 40 books have been published in the series.

The Wayne State University Press wishes to establish this fund functioning as an endowment with a gift of \$250,000 from the estate of Raphael Patai. The remaining \$57,213 from the estate will be designated for immediate spending for the Raphael Patai Series in Jewish Folklore and Anthropology.
