

Summary of Student Code of Conduct Charges

The Student Conduct Officer is responsible for investigating alleged violations of the Code of Conduct (Code) and for coordinating the conduct process. This report reflects data for the **2014-2015 Academic Year** in comparison to the **2013-2014 Academic Year**.

Misconduct cases filed with the Dean of Students Office **have increased by 58%** from the previous reporting year.

Forty-three misconduct cases were filed during the **2013-2014 Academic Year** (August 25, 2013--April 29, 2014).

Sixty-eight misconduct cases were filed during the **2014-2015 Academic Year** (August 24, 2014--May 5, 2015).
