ESTABLISHMENT OF THE NAMING OF THE YOUSIF B. GHAFARI HALL

Recommendation

It is recommended that the Board of Governors establish the naming of the North Residence Hall the *Yousif B. Ghafari Hall*.

It is the intention of the donor, Mr. Yousif B. Ghafari, to make a \$1.5 million cash gift, payable over ten years, to create the Infrastructure Research Laboratory and a \$7.5 million gift of an insurance policy on his life, to be fully paid by age 75, the proceeds from which will support student programs, scholarships and three endowed chairs. The total being pledged is \$9 million.

In gratitude and in recognition for Mr. Ghafari's generous gift, Wayne State University, with Board of Governors approval, will name the North Residence Hall the *Yousif B. Ghafari Hall*.

Background

Mr. Ghafari was born in southern Lebanon in 1952. He immigrated to the United States in the early 1970's and became an American citizen in 1978. Mr. Ghafari embarked on an ambitious and successful academic program, first receiving a Bachelor of Arts degree in Mathematics from Wayne State University in 1974, followed by a Masters of Arts in Applied Mathematics and Computer Applications, 1975, and a Master of Science in Chemical Engineering, in 1977. He completed his academic studies at Michigan State University Advance Management Program in 1992, where he received his Master of Business Administration.

Mr. Ghafari has been recognized with numerous awards and honors for his dedicated commitment to his profession and the community including Crain's Detroit Business Top 100 Executive Heroes in Southeastern Michigan, Wayne State University's Distinguished Alumni Achievement Award, Excellence in Business Award from the American Arab Chamber of Commerce. Mr. Ghafari was inducted into the International Institute of Metropolitan Detroit's Hall of Fame and his portrait is on permanent display in Detroit's Cobo Hall Convention Center.

It is recommended that the Board of Governors establish the naming of the *Richard J. Mazurek, M.D., Medical Education Commons* in the School of Medicine.

It is the intention of the donor, Mr. Nicholas J. Labedz, to make a contribution of approximately \$7.2 million to Wayne State University. In addition, Mr. Labedz intends to leave the School of Medicine thirty percent of the residue of his estate which is estimated at \$7.2 million.

The total being pledged to support the development and construction of the new Medical Education Commons in the School of Medicine is estimated at \$14.4 million.

In gratitude and in recognition for Mr. Labedz generous gift, Wayne State University, with Board of Governors approval, will name the new School of Medicine Education Commons the *Richard J. Mazurek, M.D., Medical Education Commons*.

Background

Richard J. Mazurek, M.D., a family practice physician, respected teacher and successful businessman, made an indelible mark on everything he pursued. After graduating from the Wayne State University School of Medicine in 1961, he and his life partner Nicholas J. Labedz moved to California where Dr. Mazurek built a private medical practice. Dr. Mazurek was one of the first practicing physicians to take the examination certifying him to specialize in Family Practice. While teaching at the University of California at Los Angeles, he was well known as an excellent diagnostician.

Dr. Mazurek began building real estate holdings, later joined by Mr. Labedz. At the time of Dr. Mazurek's death in October 2002, they had significant holdings in commercial and residential real estate, including a medical complex.

ESTABLISHMENT OF THE WALTER SEEGERS ENDOWED LECTURESHIP

Recommendation

It is recommended that the Board of Governors establish the Walter Seegers Endowed Lectureship.

This scholarship fund is established to provide scholarly lectures on the subject of hematology and other topics relevant to the Department of Physiology in the School of Medicine.

Background

Walter H. Seegers, was Emeritus Professor of Physiology and Chairman of the Department from 1946 to 1980. Dr. Seegers received his doctorate from the University of Iowa in 1934 and trained as a research associate with H.P. Smith. In 1934 he joined Parke, Davis and Company, for three years and in 1945 was appointed as Associate Professor at the then named Wayne College of Medicine.
